HORSEBACK RIDING AND EVENT RELEASE AND HOLD HARMLESS AGREEMENT (HEREAFTER AGREEMENT)
And WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

WHEREBY Under North Carolina law, Chapter 99E of the North Carolina General Statutes. an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities.

THEREFORE I _____ (*Full Name, Printed*) (hereafter rider/representative) for consideration received, and in return for use and enjoyment, today and on all future dates, of events and services held by Pamlico County Horseman's Association (hereafter PCHA) at the Pamlico Arena, 127 Riverview Rd., Arapahoe, NC 28529, HEREBY agree as described above and as follows:

WHEREBY and specifically this Agreement shall prohibit myself, assigns, heirs and representatives from pursuing legal action against PCHA. This prohibition shall also include members assisting in the activity. I acknowledge I am solely responsible for the decision to undertake any action on or around an equine while on the property or at the event sponsored by PCHA. I acknowledge the inherent risk of injuries associated with all horse-related activities. This includes animal behavior and reaction, the potential for rider or other riders, participants or spectators to act in a manner that may contribute to actions affecting rider, and I expressly waive any claims arising therefrom. This inherent assumption of risk includes rider's equine or other animal or action of others, whether negligent or not, and further includes but is not limited to loss or damage to equipment or personal property. All non-equine animals shall be caged or on leash such as to be in control by handler at all times.

WHEREBY I warrant all animals to be free of infection, contagious or transmittable diseases. PCHA reserves the right to refuse access, use of, or retention of any animal upon the premises that does not appear in good health or is deemed dangerous to others.

WHEREBY I am responsible for any and all damages and associated costs for repair or replacement by rider, rider's animals, and all persons I am responsible for.

HEREON I give permission to PCHA to make photographs, audio, visual or other recordings for use in written documents or social media without my inspecting the product. Nor shall I receive compensation from such use.

Laws of Pamlico County, State of North Carolina shall govern in any disputes. All disputes shall be settled in Pamlico County, NC.

In consideration for being allowed to participate in Pamlico County Horseman's Association (PCHA) events and activities, the undersigned acknowledges, appreciates, and agrees that:

Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my and/or my minor child's participation; and,

I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases.

I, for myself and or for my minor child, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS PCHA, their officers, agents, and/or volunteers, other participants, sponsors, and owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
